Sed cū satis sit in pfecto, sacrosctm Cōciliū in spūsancto legitime cōgregatū, sanctā ecclesiā catholicā representās, sit in causis fidē cōcernētib^o supra Papā, euenit, q; nec Papa ī causis hmōi, ne ab eo ad Cōciliū appellet, statuere possit, tanq; id agens, qd' ad officiū suū nō spectet vllō modo, Sitq; appellatio ipa defensio quedā, que iure diuino, naturali, & hūano cuiq; competit, neq; per principem aufferri possit.
